

**VMCC – Northern Ireland Section**  
**Kingdom of Mourne 2026 - Pre 1931 Event**  
**Friday 24th – Sunday 26th July 2026**

**Event Regulations**

1. The event will officially **start at 14:00 hrs on Friday 24th July & finish at 16:00 hrs on Sunday 26th July 2026.**
2. The event is a **non-competitive event** consisting of a number of scenic road runs and organised social gatherings.
3. The event is open to members of the Vintage Motorcycle Club (VMCC) and officially affiliated clubs. (30MCC of Ulster, IVVMCC).
4. Non-members may participate but must pay the appropriate additional event insurance fee (£5).
5. The runs on the event are open to machines manufactured prior to 1<sup>st</sup> January 1931.
6. Whilst suggested route sheets will be supplied, event participants are not obliged to participate on any run, nor follow any suggested route.
7. All participants must complete and submit the official **Entry Form** and appropriate **fees**.
8. All fees for the event must be paid by the date shown on the entry form. Booking after this date cannot guarantee availability of items shown on the entry form.
9. Some items will need to be booked and paid for up-front, other items may still need to be booked but paid for on the day.
10. The entry form does include booking of accommodation. However, if accommodation at the event venue is fully booked, entrants must make their own accommodation arrangements.
11. Booking of any items may only be changed (added or removed) with the permission of the Organiser and/or, as appropriate, the event venue management, and subject to cut off dates and any additional fees.
12. Fees will only be returned if pre-booked items are removed, and do not have to be paid for by the VMCC Northern Ireland Section.
13. Under 18's may participate subject to completion of the relevant VMCC forms at signing on.
14. All participants must 'sign on' on arrival at the designated area for the event and show a valid VMCC or Affiliated Club membership card.
15. At signing on, all participants will declare that:
  - a. They have had the opportunity to read & understand the Regulations and such Supplementary Regulations as have or may be issued for the event and agree to be bound by them.
  - b. They are physically and mentally fit to take part in the event and are competent to do so.
  - c. They understand the nature and type of event and the risk inherent when entering and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers/officials.
  - d. They will not seek to claim against the Vintage Motor Cycle Club Ltd, the organisers or their officials, the landowners, the promoter or other bodies or individuals connected with the event in respect of any loss, damage, costs, claims or expenses that they have suffered or incurred, except for liability for death or personal injury arising out of negligence of the Vintage Motor Cycle Club Ltd, the organisers or their officials, the landowners, the promoter or other bodies or individuals connected with the event.
  - e. As a driver, they are correctly licenced appropriate to Northern Ireland legislation.
  - f. All their machines which participate in the event shall be suitable and proper for its purpose, must be roadworthy, correctly taxed, tested and insured appropriate to Northern Ireland legislation.
